## PURPOSE

The main goal of the Seminar is to obtain a picture of the current challenges and problems of criminal policy and criminal law as perceived by young penalists. For this reason, the Seminar is open to participations focused on any topic falling within that overarching theme, so that an entire generation may give account of the issues that trigger their interest and which, as such, are likely to dominate the debate in the years to come in the legal area.

## SUMBISSION AND SELECTION OF PAPERS

Those interested in presenting a paper at the Seminar are invited to submit proposal with a maximum of 1.400 words (circa 4 pages) in a Word file to one of the following e-mail addresses: <u>idp@uclm.es</u> and <u>aidp.portugal@gmail.com</u>, before of 1st May. By the 30<sup>th</sup> of May 2020, the Selection Committee shall make public their decision on the selected papers.

These papers will be presented at the Seminar in different panels organised based on the affinity of the topics, each presentation having a duration of approximately 15 minutes. Presentations may draw on doctoral theses or other original research projects developed by the candidate and may be carried out in Spanish, Portuguese or English.

This call is aimed at young penalists (not over 35 years old) who are members in the AIDP. Young penalists who are not members of the Association may still participate subject to a registration fee of  $\notin$  45, equivalent to the annual membership in the Association.

# PUBLICATION

The Selection Committee shall elect 10 papers for publication in the *Libri* series of the International Review of Penal Law (<u>http://www.penal.org/en/aidp-iapl-publications</u>). Details on the length, formal requirements and deadline for submission of selected papers will be provided at a later moment.
